OFFICE MEMORANDUM

Sub :- Suspension of names of HCO's from the list of approved HCOs under CGHS, Pune.

With reference to Ministry's Office order dated 12.1.2016 (Copy enclosed) the HCO's as per attached list 'A' which have not applied for QCI inspection within stipulated time period stands suspended w.e.f.31.1.2016 for a period of three months or till they get recommendation by QCI, whichever may be later. However, if they fail to get QCI recommendation within six months, they will be permanently removed from CGHS Panel.

Further the HCO's as per attached list 'B' which have not been recommended by QCI stands suspended w.e.f.31.1.2016 & are given an opportunity to rectify the deficiencies within three months & submit a revised recommendation by QCI within the stipulated time period of three months but not later than six months failing which their suspension may be made permanent.

During the period of suspension these HCOs should not treat any CGHS beneficiaries, serving as well as pensioners. However Patients admitted upto 31.1.2016 shall not be discharged in view of this order & treatment should be continued till the recovery.
